- a.) The Board of Directors of Monroe Security & Safety Systems Local Development Corporation shall have, among its total membership, Directors appointed as follows: two (2) members appointed by the County Executive; one (1) member appointed by the County Executive upon the recommendation of the Executive Director of the Monroe County Water Authority; one (1) member appointed by the County Executive upon the recommendation of the Majority Leader of the Monroe County Legislature; and one (1) member appointed by the County Executive upon the recommendation of the Minority Leader of the Monroe County Legislature.

- b.) The contract between Monroe County and Monroe Security & Safety Systems Local Development Corporation shall require its compliance with the New York Public Authorities Accountability Act, as amended from time to time.
- c.) The contract between Monroe County and Monroe Security & Safety Systems Local Development Corporation shall require its compliance with the New York Freedom of Information Law (N.Y. Public Officers Law §§ 84-90, as amended from time to time).
- d.) The contract between Monroe County and Monroe Security & Safety Systems Local Development Corporation shall require its compliance with the New York Open Meetings Law (N.Y. Public Officers Law §§ 100-111, as amended from time to time).
- e.) The contract between Monroe County and Monroe Security & Safety Systems Local Development Corporation shall require that the Monroe County Director of Public Safety, or his or her designee, be a member of the selection committee for any and all contracts entered into by Monroe Security & Safety Systems Local Development Corporation, and any subcontracts thereof.
- f.) The contract between Monroe County and Monroe Security & Safety Systems Local Development Corporation shall contain a non-appropriations clause with the following terms:

Notwithstanding anything herein to the contrary, the obligations of the County hereunder shall be deemed executory only to the extent of moneys appropriated and available for the purposes to which this Agreement relates and no liability on account of this Agreement shall be incurred by the County beyond the amount of such appropriated and available moneys. In the event that, during any fiscal period of the County, sufficient funds are not appropriated by the County's governing body for the payment of the Total Annual Payment during the County's next fiscal period, then the County may terminate this Agreement as of its then-current fiscal period and shall not be obligated to pay any Total Annual Payments beyond such fiscal period. The County agrees to give Monroe County and Monroe Security & Safety Systems Local Development Corporation written notice of such termination at least 45 days prior to the end of the then-current fiscal period, or, if nonappropriation has not occurred by that date, immediately upon nonappropriation.

PROVIDING THAT INTRO. NO. 310 OF 2009 BE AMENDED

Be It Moved that Intro. No. 310 of 2009, be amended as follows:

Section 1. The County Executive, or her designee, is hereby authorized to execute a contract, and any amendments thereto, with Monroe Security & Safety Systems Local Development Corporation, for the provision of public safety and security systems and services, at an average annual cost of \$11,200,000 per year, for a period of twenty (20) years- under the following conditions:

- a) The Board of Directors of Monroe Security & Safety Systems Local Development Corporation shall have, among its total membership, Directors appointed as follows: ~~two~~ ~~three~~ (2) (3) members appointed by the County Executive; ~~one~~ (1) member appointed by the County Executive upon the recommendation of the Executive Director of the Monroe County Water Authority; ~~one~~ ~~two~~ (1) (2) members appointed by the County Executive upon the recommendation of the Majority Leader of the Monroe County Legislature; and ~~one~~ ~~two~~ (1) (2) members appointed by the County Executive upon the recommendation of the Minority Leader of the Monroe County Legislature. All appointees shall have qualifications in at least one area of public safety, either in fire, police or emergency medical services including communications therein, with no less than 5 years of such experience.

b) The contract between Monroe County and Monroe Security & Safety Systems Local Development Corporation shall require its compliance with the New York Public Authorities Accountability Act, as amended from time to time.

c) The contract between Monroe County and Monroe Security & Safety Systems Local Development Corporation shall require its compliance with the New York Freedom of Information Law (N.Y. Public Officers Law §§ 84-90, as amended from time to time).

d) The contract between Monroe County and Monroe Security & Safety Systems Local Development Corporation shall require its compliance with the New York Open Meetings Law (N.Y. Public Officers Law §§ 10(.).111, as amended from time to time).

e) The contract between Monroe County and Monroe Security & Safety Systems Local Development Corporation shall require that the Monroe County Director of Public Safety, or his or her designee, be a member of the selection committee for any and all contracts entered into by Monroe Security & Safety Systems Local Development Corporation, and any subcontracts thereof. *the local development corporation to obtain written approval of the Monroe County Director of Public Safety, or his/her designee, of all contracts or subcontracts, prior to awarding any contracts.*

f) The contract between Monroe County and Monroe Security & Safety Systems Local Development Corporation shall contain a non-appropriations clause with the following terms:

Notwithstanding anything herein to the contrary, the obligations of the County hereunder shall be deemed executory only to the extent of moneys appropriated and available for the purposes to which this Agreement relates and no liability on account of this Agreement shall be incurred by the County beyond the amount of such appropriated and available moneys. In the event that, during any fiscal period of the County, sufficient funds are not appropriated by the County's governing body for the payment of the Total Annual Payment during the County's next fiscal period, then the County may terminate this Agreement as of its then-current fiscal period and shall not be obligated to pay any Total Annual Payments beyond such fiscal period. The County agrees to give Monroe County and Monroe Security & Safety Systems Local Development Corporation written notice of such termination at least 45 days prior to the end of the then-current fiscal period, or, if nonappropriation has not occurred by that date, immediately upon nonappropriation.

g) *The contract between Monroe County and Monroe Security & Safety Systems Local Development Corporation shall require the local development corporation to file with the Clerk of the Monroe County Legislature quarterly financial statements and the annual audited financial statements for the period of the contract.*
